Taxpayers using our online payment system are encouraged to verify that payment has been deducted from their checking/savings account to insure payment has been properly remitted to the Town of Winchester. Any payments rejected due to NSF, account number errors, etc. that cause a payment to become delinquent are subject to interest and penalties in accordance with Connecticut State Statutes.

All tax bills have a 30 day grace period. A bill due January 1 must be paid by February 1 to avoid interest charges. Interest is calculated at the rate of 1-1/2% per month (18% annual interest) from the DUE DATE of the bill. (EX: bill due 7/1 paid in Aug late, owes two months interest-3% or minimum of \$2)

Address return envelopes provided to you with your tax bills are for CURRENT TAX BILLS ONLY!! If a payment is late, do NOT send it to the Hartford address as the bank cannot process late bills. Late payments MUST be mailed directly to tax office address.
