VENDOR PERMITS

- ✓ Please find attached the Vendor Permit Application as well as the Town Ordinance regarding Vending. (Sec. 12a. Peddling)
- ✓ Please complete the attached form and return with the **\$25 fee** (\$50 for fishing derby).
- ✓ If issuing a check, please make the check out to the Town of Winchester. The Police Chief will review and sign the Vendor Permit. **No vending can begin without the signed Vendor Permit.**
- ✓ If you are vending food, a copy of your certificate from Torrington Area Health will need to be included with your vending permit application when submitted for approval.
- ✓ If you are vending on private property, you will need to get **written permission from the property owner** and that will also need to be included with your vending permit application.
- ✓ As per the attached ordinance, **vending is not allowed on any town owned recreation field or facility including lake.**
