



LEGAL NOTICE

TOWN OF WINCHESTER

NOTICE IS HEREBY GIVEN TO ALL TAXPAYERS of the Town of Winchester, City of Winsted, Connecticut that a tax with a Mill Rate of 31.91 laid on the assessment date of October 1, 2013 is due and payable at the office of the Collector of Revenues as follows:

FIRST INSTALLMENT DUE: JULY 1, 2014      LAST DAY TO PAY: August 1, 2014

SECOND INSTALLMENT DUE: JANUARY 1, 2015      LAST DAY TO PAY: February 2, 2015

If payments not received or postmarked by the **LAST DAY TO PAY** listed above, the tax bill shall become delinquent and subject to interest from the initial due date.

INTEREST shall be charged at the rate of one and one-half percent (1 ½%) for each month or fraction thereof. (18% annual percentage rate) **MINIMUM INTEREST SHALL BE NO LESS THAN \$2.00.**

ALL MOTOR VEHICLE TAXES, as well as Real Estate and Personal Property taxes in the amount of \$100 or less are due **IN FULL** on **JULY 1, 2014** and must be paid on or before **August 1, 2014.**

PAYMENT INFORMATION:      Avoid long lines and pay promptly or make payment by mail.
