TOWN OF WINCHESTER SNOW PLOW RIDE-ALONG PROGRAM

RULES

1. Participants must be 18 years of age, or older. Proof of age will be required.
2. Participants must be a Winchester resident.
3. Participants cannot request a specific snow plow route. Participants will not be assigned to the snow plow route that traditionally plows their street and neighborhood.
4. Riders must be able to physically climb into and out of the plow truck.
5. Rides will depart from and end at the Public Works Facility, located at 189 Rowley Street. Participants will not be picked up or dropped off at alternate locations.
6. Participants should dress appropriately for the weather conditions. Dressing in layers, and sturdy boots are recommended. Please note that truck cabs are kept warm to reduce ice buildup on the windshields
7. Rides will last approximately ninety (90) minutes.
8. Two or three days before the next storm, the department will contact applicants, and they will be assigned a time for their ride-along.
9. Rider participation is at the discretion of the Director of Public Works.
